TERMS AND CONDITIONS

1. The allottee with his family should reside in the quarter and should not subject or allow any other persons to reside with him with out obtaining specific permission of the Executive Officer.
2. He should abide by the terms and conditions as laid down by the management of the above institution and now in force and also is modified from time to time.
3. No H.R.A will be drawn and paid to the allottee. He should pay 12% of Pay or 10% gross if he availed HBA, whichever is higher and water charges Rs.50/- per month and Electrical Charges as laid by the A.P.S.E.B authorities. The allottee is informed that present allotment is purely temporary and does not confer his any right.
4. The allottee is liable to vacate within a week from the date of advance notice if any given to him in case alternative accommodation is provided. In case no alternative accommodation is given he should vacate with in a period of 30 days.
5. If he violates the above conditions he has to pay penalty grant levied by the Executive Officer from the date of expiry of the prescribed time in the notice.
6. He should acknowledge the receipt of furniture, Electrical fittings, etc., available in the quarter and hand over the same at the time of vacation.
7. Any violation of the above conditions by the allottee, the allocation is deemed to have been cancelled.
8. Quarter allotted to Principal, GSL Dental College on free of cost basis.
